WHEREAS, on March 12, 2020 the World Health Organization (WHO) declared COVID-19 a "pandemic";

WHEREAS, the Department of Health has elevated the outbreak as Code Red Sub-Level 2 due to the "continued and accelerated spread of the COVID-19 as has been observed within NCR;

WHEREAS, to contain the effect that will be brought by the pandemic, Resolution No. 11 (Series of 2020) issued by the Inter-Agency Task Force for the Management of Emerging Infectious Disease was adopted by *His Excellency, President Rodrigo Roa Duterte*, effectively placing the entire National Capital Region (NCR) under community quarantine;

WHEREAS, as of March 16, 2020 10:00am, the City of Muntinlupa noted the rise of persons affected by the COVID 19 to wit: Persons under Monitoring 33; Patients under Investigation, 38 and; one (1) confirmed case of COVID 19 – infected;

WHEREAS, while said figures is less in comparison to neighboring NCR cities/ Municipalities, the imposition of community quarantine and curfew in the City of Muntinlupa will greatly affect the marginalized sectors of the community not only in terms of health but also in the aspect of economy:

WHEREAS, on March 13, 2020, the Local Disaster Risk reduction and Management Council of the City issued a Resolution recommending to the Sanggunian the declaration of a State of Calamity, noting the need to access the Quick Respond Fund to address the various need of the constituency;
