

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others":

WHEREAS, Article 86 (b) (1) (vi) of the Local; Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"

WHEREAS, one of the priority programs of the City Government of Muntinlupa is the improvement of garbage collection and disposal service in order to ensure the cleanliness of the city;

WHEREAS, the 9th Sangguniang Panlungsod approved Resolution No. 2020-208 for the extension from January 1 to March 31, 2020 amounting to Sixty Thousand Fifty-Four Thousand Pesos (Php60,054,000.00) based on the contract price:

WHEREAS, the City Government of Muntinlupa advertised the Invitation to apply for Eligibility and to Bid of the Contract for Garbage Collection and Disposal Services of the City of Muntinlupa for the Fiscal Year 2020 once in a newspaper of nationwide general circulation and posted the same in the conspicuous place at the premises of the City Hall of Muntinlupa and at PhilGEPS, Website and Bulletin;

WHEREAS, the Members of the *Bids and Awards Committee (BAC)* and the *Technical Working Group (TWG)* hereby recommends the award, based on the foregoing findings, to **Leonel Waste Management Corporation** for approval of the Hon. City Mayor Atty. Jaime R. Fresnedi;

WHEREAS, the New Contract shall be effective for the interim period starting January 1, 2020 to December 31, 2020;

WHEREAS, there is a budget appropriation for Contract for Garbage Collection and Disposal Services amounting to Two Hundred Forty Million Two Hundred Sixteen Thousand Pesos (Php240,216,000.00) from the Executive Budget 2020 less the price of extension of contract (January 1 to March 31, 2020 – Php60,054,000.00);

NOWTHEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, authorizing the Hon. City Mayor Atty. Jaime R. Fresnedi to enter into and sign the new contract of services in behalf of the City Government of Muntinlupa with Leonel Waste Management Corporation for the garbage collection and disposal services for Fiscal Year 2020 amounting to Two Hundred Forty Million Two Hundred Sixteen Pesos (Php240,216,000.00) which amount shall be taken from the 2020 Executive Budget.

RESOLVED, that the *City Accounting* and the *City Treasurer* shall deduct from the Contract Price herein stated, the amount of **Sixty Thousand Fifty-Four Thousand Pesos (Php60,054,000.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-208**.

RESOLVED FUTHER, that Leonel Waste Management Corporation is mandated to institute and strictly implement the health and safety of its employees (paleros) by provision of safety gears in the conduct of collection of garbage/waste products;

RESOLVED FINALLY, that the City Legal Office shall incorporate in the **Contact** of **Services** the appropriate penalties for non-compliance/violation of the immediately preceding paragraph;

APPROVED, by the 9th Sangguniang Panlungsod this 20th day of March, 2020, on its 4th Special Session.
