WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, Article 86 (b) (1) (vi) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"

WHEREAS, one of the priority programs of the City Government of Muntinlupa is the improvement of garbage collection and disposal service in order to ensure the cleanliness of the city;

WHEREAS, the 9th Sangguniang Panlungsod approved **Resolution No. 2020-208** for the extension from **January 1 to March 31, 2020** amounting to **Sixty Thousand Fifty-Four Thousand Pesos (Php60,054,000.00)** based on the contract price:
