FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE NEW CONTRACT WITH SKYLIMIT PRINTING & ASCEND ENTERPRISES FOR PRINTING AND DELIVERY OF LINGKOD BAYAN FOR FISCAL YEAR 2020, IN THE AMOUNT OF ONE MILLION THREE HUNDRED FOURTY-FOUR THOUSAND PESOS (PHP1,344,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, Article 86 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **printing and delivery of Newsletter** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the 9th Sangguniang Panlungsod approved **Resolution No. 2020-209** for the **Extension of Contract** for the interim period starting January 1, 2020 to March 31, 2020 the contract price is **Three Hundred Fifty-Eight Thousand Eight Hundred Pesos (PHP358,800.00)** to wit:

- a) **Regular Issue: Php 6.55 per copy**
- b) **Special Issue: Php10.25 per copy**

WHEREAS, there is a budget appropriation for printing and delivery of Lingkod Bayan amounting to **One Million Four Hundred Thirty-Five Thousand Two Hundred Pesos (Php1,435,200.00)** from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa the New Contract with **Skylimit Printing & Ascend Enterprises** for Printing and Delivery of Lingkod Bayan for Fiscal Year 2020, in the amount of **One Million Three Hundred Forty-Four Thousand Pesos (Php1,344,000.00)** which amount shall be taken from the 2020 Executive Budget.

RESOLVED, that the **City Accounting** and the **City Treasurer** shall deduct from the Contract Price herein stated, the amount of **Three Hundred Fifty-Eight Thousand Eight Hundred Pesos (PHP358,800.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-209**.

RESOLVED FURTHER, that the approval of the herein **New Contract** shall be subject to the submission of certification of availability of funds.

APPROVED, by the 9th Sangguniang Panlungsod this 20th day of March 2020, on its 4th Special Session.
