A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR NEW CONTRACT OF SECURITY SERVICES FOR FISCAL YEAR (FY) 2020 IN THE AREA MORE SPECIFICALLY: THE COLEGIO DE OF RESPONSIBILITY (AOR), **POSADAS** AVENUE, BARANGAY SUCAT, MUNTINLUPA, LOCATED IN MUNTINLUPA CITY AMOUNTING TO FOUR MILLION EIGHT HUNDRED THIRTY-SIX THOUSAND NINETY-SIX PESOS (PHP4,836,096.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Direct Contracting, Repeat Order, Shopping and Negotiated Bidding, Procurement";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior

authorization by the Sangguniang concerned",

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the Security & Protection Services in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, a public bidding for the 2020 Security & Protection Services contract has been substantially undertaken by the Bids Awards Committee (BAC);


WHEREAS, the 9th Sangguniang Panlungsod approved *Resolution No. 2020-210* for the Extension of Contract from January 1, to March 31, 2020 the contract price is Six Hundred Seventy-Nine Thousand One Hundred Eighteen Pesos and 60/100 (PHP679,118.60);

WHEREAS, there is available funds from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsond of Muntinlupa City, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) between the City Government of Muntinlupa and Best Security Agency for the Contract of Security Services for Fiscal Year (FY) 2020 in the Area of Responsibility (AOR), More Specifically: The Colegio De Muntinlupa, located in Posadas Avenue, Barangay Sucat, Muntinlupa City amounting to Four Million Eight Hundred Thirty-Six Thousand Ninety Six Pesos (Php4,836,096.00) shall be taken from the 2020 Executive Order.

RESOLVED, that the *City Accounting* and the *City Treasurer* shall deduct from the Contract Price herein stated, the amount of Six Hundred Seventy-Nine Thousand One Hundred Eighteen Pesos and 60/100 (PHP679,118.60) representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of Resolution No. 2020-210.

APPROVED, by the 9th Sangguniang Panlungsod this 20th day of March 2020, on its 4th Special Session.
