WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, "**xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned**";

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "**in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement**";
