A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR THE NEW CONTRACT OF SECURITY SERVICES FOR FISCAL YEAR 2020 AT THE OSPITAL NG MUNTINLUPA (OSMUN) LOCATED AT CIVIC DRIVE, CORPORATE CITY, BARANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO TEN MILLION FIVE HUNDRED SIXTY-TWO THOUSAND SEVEN HUNDRED SEVENTY-FOUR PESOS AND 64/100 (PHP10,562,774.64) SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, "xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement";

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **Security & Protection Services** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the 9<sup>th</sup> Sangguniang Panlungsod approved *Resolution No. 2020-225* for the Extension of Contract from January 1 to March 31, 2020 amounting to Two Million Two Hundred Forty-Nine Thousand Nine Hundred Four Pesos and 29/100 (Php2,249,904.29);

WHEREAS, there is available fund from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa City, to authorize the City Mayor Atty. Jaime **R. Fresnedi** to enter and sign the Memorandum of Agreement (MOA) between the City Government of Muntinlupa and Security Services for the New Contract of Security Services for Fiscal Year 2020 at the Ospital ng Muntinlupa (Osmun) located at Civic Drive, Corporate City, Barangay Alabang, Muntinlupa City amounting to Ten Million Five Hundred Sixty-Two Thousand Seven Hundred Seventy-Four Pesos and 64/100 (Php10,562,774.64) shall be taken from 2020 Executive Budget..

**RESOLVED**, that the *City Accounting* and the *City Treasurer* shall deduct from the Contract Price herein stated, the amount of **Two Million Two Hundred Forty-Nine Thousand Nine Hundred Four Pesos and 29/100 (Php2,249,904.29)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-225**.

APPROVED, by the 9<sup>th</sup> Sangguniang Panlungsod this 20<sup>th</sup> day of March, 2020, on its 4<sup>th</sup> Special Session.
