FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE NEW CONTRACT OF SERVICE WITH LITA INES CANTEEN FOR SUPPLY AND DELIVERY OF DIETARY SERVICES FOR THE FISCAL YEAR 2020, IN THE AMOUNT OF TWELVE MILLION THREE HUNDRED FIFTEEN THOUSAND FOUR HUNDRED PESOS (PHP12,315,400.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, "xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "in & order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Shopping and Negotiated Repeat Order, Direct Contracting, Bidding, Procurement";

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the *supply and delivery of dietary services* in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the Sangguniang Panlungsod approved Resolution No. 2020-214 for the extension of contract from January 1 to March 31, 2020 amounting to Three Million Ninety-Four Thousand One Hundred Forty-Three Pesos and 75/100 (PHP3, 094.143.75):

WHEREAS, there is a budget appropriation for *supply and delivery of dietary services* from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter and sign in behalf of the City Government of Muntinlupa the New Contract of Service with Lita Ines Canteen for Supply and Delivery of Dietary Services for the Fiscal Year 2020, in the amount of Twelve Million Three Hundred Fifteen Thousand Four Hundred Pesos (Php12,315,400.00) which amount shall be taken from the 2020 Executive Budget.

RESOLVED, that the *City Accounting* and the *City Treasurer* shall deduct from the Contract Price herein stated, the amount of Three Million Ninety-Four Thousand One Hundred Forty-Three Pesos and 75/100 (PHP3, 094,143.75) representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of Resolution No. 2020-214.
