A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE NEW CONTRACT OF SERVICE WITH INTEGRATED WASTE MANAGEMENT INC., FOR THE COLLECTION, TREATMENT & DISPOSAL OF VARIOUS HOSPITAL WASTE FOR THE FISCAL YEAR 2020, IN THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHTY PESOS (PHP1,280,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, *"in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement"*;

WHEREAS, Section 53 of the same Article xvi, as implemented by Section 53, Rule XVI of the Revised IRR pf R A. 9184, *"authorizes Negotiated Procurement as an alternative mode of procurement in the following cases"*;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, *"xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"*;

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **hospital waste collection, treatment and disposal services** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the 2020 **hospital waste collection, treatment and disposal services** contract of **Integrated Waste Management, Inc. (IWMI)** with the city Government of Muntinlupa was awarded as a result of competitive bidding accordance with the provision of Republic Act No. 1984 or the Government Procurement Reform Act" and its Implementing Rules and Regulations (IRR);

WHEREAS, the public bidding for the 2020 Collection, Treatment & Disposal of various hospital waste has been substantially undertaken by the City Government, with the Bids and Awards Committee (BAC);

WHEREAS, the 9th Sangguniang Panlungsod approved **Resolution No. 2020-212** for extension of contract from January 1 to March 31, 2020, for the Collection, Treatment & Disposal of various hospital waste amounting to **Two Hundred Thousand Pesos (Php200,000.00)**;

WHEREAS, there is a budget appropriation for the Collection, Treatment & Disposal of various hospital waste for the year 2020;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th **Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** to enter and sign in behalf of the City Government of Muntinlupa the New Contract of Service with Integrated Waste Management Inc., for the **Collection, Treatment & Disposal of Various Hospital Waste** for the Fiscal Year 2020, in the amount of **One Million Two Hundred Eighty Pesos (Php1,280,000.00)** which amount shall be taken from the 2020 Executive Budget.

RESOLVED, that the **City Accounting** and the **City Treasurer** shall deduct from the Contract Price herein stated, the amount of **Two Hundred Thousand Pesos (Php200,000.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-212**.

APPROVED, by the 9th Sangguniang Panlungsod this 20th day of March 2020, on its 4th Special Session.




