A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF OSPITAL NG MUNTINLUPA (OSMUN) FOR NEW CONTRACT SERVICE WITH POLOVENT ENTERPRISES, FOR THE SERVICE OF MECHANICAL VENTILATOR RENTAL SERVICES FOR USE OF THE OSPITAL NG MUNTINLUPA FOR THE FISCAL YEAR 2020 IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND PESOS (PHP2,862,000.00) AMOUNT SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, *"in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement"*;

WHEREAS, Section 53 of the same Article xvi, as implemented by Section 53. Rule XVI of the Revised IRR pf R.A. 9184, *"authorizes Negotiated Procurement as an alternative mode of procurement in the following cases"*;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, *"xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"*;

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **mechanical ventilator** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, as the only public hospital of the City of Muntinlupa capable of providing tertiary level health care, it is essential that the facility be enabled to contract with third party provider's equipment's crucial to sustain and save lives of our patient, when all equipment of the hospital is already in use;

WHEREAS, the 9th Sangguniang Panlungsod approved **Resolution No. 2020-215** for the extension of contract from January 1 to March 31, 2020 amounting to **Four Hundred Ninety-Eight Thousand Seven Hundred Fifty Pesos (Php498,750.00)**;

WHEREAS, the company shall give additional 20% discount to Senior Citizens and Person with Disability;

WHEREAS, the Memorandum of Agreement (MOA) entered into by the Chief Executive with **Polovent Enterprises** shall comply with the provision under Republic Act No. 9184, otherwise known as the General Procurement Act.

WHEREAS, there is available fund from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) in behalf of Ospital Ng Muntinlupa (Osmun) New Contract Service With Polovent Enterprises, For The Service Of Mechanical Ventilator Rental Services For Use Of The Ospital Ng Muntinlupa For The Fiscal Year 2020 In The Amount Of Two Million Eight Hundred Sixty-Two Thousand Pesos (Php2,862,000.00) Amount Shall Be Taken From 2020 Executive Budget.

RESOLVED, that the **City Accounting** and the **City Treasurer** shall deduct from the Contract Price herein stated, the amount of **Four Hundred Ninety-Eight Thousand Seven Hundred Fifty Pesos (Php498,750.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-215**.
