**WHEREAS**, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

**WHEREAS**, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, ***“xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned”***;

**WHEREAS**, Section 48, Article XVI of Republic Act No. 9184, provides that, ***“in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement”***;

**WHEREAS**, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **supply and delivery of Medical Gases** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in order to attain this objective and in view of the expiration of the contract for the **supply and delivery of Medical Gases** for the Ospital ng Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

**WHEREAS**, the 2020 supply and delivery of Medical Gases contract of the **Linde Philippines, Inc.**, with the city government was awarded as a result of competitive bidding in accordance with the provisions of Republic Act No. 1984 or the Government Procurement Reform Act" and its Implementing Rules and Regulations (IRR), has duration until December 31, 2019;

**WHEREAS**, the public bidding for the 2020 supply and delivery of Medical Gases has been substantially undertaken by the City Government, with the Bids and Awards Committee (BAC);

**WHEREAS**, the 9<sup>th</sup> Sangguniang Panlungsod approved **Resolution No. 2020-211** for the extension of contract for the supply and delivery of Medical Gases for three (3) Months extension of the contract amounting to **Two Million Four Hundred Ninety-Nine Thousand Nine Hundred Ninety-Seven Pesos (Php2,499,997.00)**;

**WHEREAS**, there is available fund from the 2020 Executive Budget;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter in to and sign in behalf of the City Government of Muntinlupa the New Contract With Linde Philippines, Inc., for the supply and delivery of Medical Gases for the Fiscal Year 2020, in the amount of Fourteen Million Fifty-Seven Thousand Nine Hundred Twenty-Six Pesos and 12/100 (Php14,057,926.12) which amount shall be taken from the 2020 Executive Budget.

**RESOLVED**, that the **City Accounting** and the **City Treasurer** shall deduct from the Contract Price herein stated, the amount of **Two Million Four Hundred Ninety-Nine Thousand Nine Hundred Ninety-Seven Pesos (Php2,499,997.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-211**.

**APPROVED**, by the 9<sup>th</sup> Sangguniang Panlungsod this 20<sup>th</sup> day of **March, 2020**, on its 4<sup>th</sup> Special Session.
