FRESNEDI TO ENTER AND SIGN THE NEW CONTRACT OF SERVICE IN BEHALF OSPITAL NG MUNTINLUPA (OSMUN) WITH DEARJOHN SERVICES REPRESENTED BY THE GENERAL MANAGER BERNADETTE P. GARIN, THE SERVICE OF OUTSOURCED HOUSEKEEPING FOR THE OSPITAL NG MUNTINLUPA (OSMUN) FOR THE FISCAL YEAR 2020 AMOUNTING TO NINE MILLION NINE HUNDRED FORTY-NINE THOUSAND FIVE HUNDRED TWENTY-TWO PESOS AND 80/100 (PHP9,949,522.80).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(vii) of Republic ACT No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligation and such other document upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, state that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, "in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement";

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the goods and services for the **outsourced housekeeping services** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the 9th Sangguniang Panlungsod approved **Resolution No. 2020-216** for the Extension of Contract for the **outsourced housekeeping services** from **January 1 to March 31, 2020** amounting to **Two Million Four Hundred Twenty-Two Thousand Eight Hundred Pesos (Php2,422,800.00)**;

WHEREAS, there is budget allocation for the 2020 Executive Budget under the Ospital ng Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter and sign the **new contract of service** in behalf Ospital ng Muntinlupa (OSMUN) with Dearjohn Services represented by the General Manager Bernadette P. Garin, the service of **outsourced housekeeping** for the Ospital ng Muntinlupa (OSMUN) for the Fiscal Year 2020 amounting to **Nine Million Nine Hundred Forty-Nine Thousand Five Hundred Twenty-Two Pesos and 80/100 (Php9,949,522.80)** which amount shall be taken from the 2020 Executive Budget.

RESOLVED, that the **City Accounting** and the **City Treasurer** shall deduct from the Contract Price herein stated, the amount of **Two Million Four Hundred Twenty-Two Thousand Eight Hundred Pesos (Php2,422,800.00)** representing the three-month Extension of Contract granted by the Sangguniang Panlungsod by virtue of **Resolution No. 2020-216**.

APPROVED, by the 9th Sangguniang Panlungsod this 20th day of March, 2020, on its 4th Special Session.






