A RESOLUTION AUTHORIZING THE CITY MAYOR TO PROCURE POLYMERASE CHAIN REACTION (PCR) MACHINES AND TESTING KITS, FOR USE BY THE OSPITAL NG MUNTINLUPA, SUBJECT TO THE APPROVAL OF THE DEPARTMENT OF HEALTH (DOH), WHICH SHALL BE FUNDED UNDER THE 30% QUICK RESPONSE FUND OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (QRF-LDRRMF).

WHEREAS, the World Health Organization (DOH) has declared the spread of COVID-19 as pandemic on March 11, 2020;

WHEREAS, following such declaration of the World Health Organization (WHO), *President Rodrigo Duterte* on March 16, 2020, placed the entire Luzon under Enhanced Community Quarantine until April 12, 2020;

WHEREAS, policies to help curb the exponential rise in the number of those afflicted by COVID-19 are being passed and implemented by both National and Local Authorities;

WHEREAS, the City of Muntinlupa, as of March 23, 2020, 3:00pm, has a total of 8 confirmed COVID-19 cases; 156 *Persons Under Monitoring (PUM)* and 68 *Persons Under Investigation (PUI)*;

WHEREAS, the statistical data shows that a more aggressive medical intervention is needed to effectively segregate, for quarantine purposes, the virus-stricken constituents of Muntinlupa City;

WHEREAS, early detection of a **COVID-19**-infected person can deter the spread of the virus and the purchase of **Polymerase Chain Reaction (PCR)** machines and testing kits is critical in the determination of the medical assistance which must be administered to the patients;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to procure **Polymerase Chain Reaction (PCR)** machines and testing kits, subject to the approval of the **Department of Health (DOH)**, which shall be funded under the **30% Quick Response Fund of the Local Disaster Risk Reduction Management Fund (LDRRMF)**;

RESOLVED FURTHER, that the purchase of the **Polymerase Chain Reaction (PCR)** machines and testing kits shall be subject to the Guidelines and Regulatory Standards of the **Department of Health (DOH)**;

RESOLVED FINALLY, that the Ospital ng Muntinlupa shall house the Testing Area of the **Polymerase Chain Reaction (PCR)** machine and testing kit.
