A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REGARDING THE INTERIM REIMBURSEMENT PROGRAM TO ENABLE HOSPITALS TO RESPOND TO THE COVID-19 PANDEMIC.

WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the new Local Government Code of 1991, provides that, ***“every local government unit created or reorganized under this code is a body politic and corporate endowed with the powers to exercise by it in conformity with law.”***

WHEREAS, Section 22 of the same Code states that, “every local Government Unit, as a corporation, shall have the following powers:

WHEREAS, Article 86 (b) (1) (vi) and Article 86 (b) (1) (viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;***

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that. ***"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government unit without prior authorization by the Sangguniang concerned"***;

WHEREAS, under *PhilHealth Circular Number 0034, Series of 2013*, states that, ***"in the event of the Government's formal declaration of a state of calamity or state of emergency, the Government will provide public health services for all groups, including displaced communities and those in environmentally endangered areas, and free care for those who are unable to afford it"***;

WHEREAS, the privilege to those affected by a fortuitous event such as the COVID-19 pandemic being provided by PhilHealth includes the ***Interim Reimbursement Mechanism*** for Health Care Provider such as the **Ospital ng Muntinlupa**;

WHEREAS, under the said **Interim Reimbursement Program**, the Ospital ng Muntinlupa may avail of the **Sixty-Six Million One Hundred Ninety-Five Thousand Pesos (Php66,195,000.00)** facility which will aid the **Ospital ng Muntinlupa** to continuously provide health care services to affected Philhealth beneficiaries;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod ng Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with **Philippine Health Insurance Corporation (Philhealth)** regarding the **Interim Reimbursement Program** to enable Hospitals to respond to the Covid-19 Pandemic.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 6th day of April 2020, on its 39th Regular Session.
