WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, "*The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx.*";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "*(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "*unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.*";

WHEREAS, the Department of Agriculture (DA) and the City Government of Muntinlupa, recognizing the benefits of the **Urban Agriculture**, conclude that the installation and maintenance of **Urban Garden** is in line with the Department of Agriculture's promotion of Urban Agriculture to aid in food security and vegetable consumption for its beneficiaries;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and enter into a **Memorandum of Understanding (MOU)** with the Department of Agriculture (DA) represented by Secretary William D. Dar, Ph.D. regarding the installation and maintenance of Urban Garden.

RESOLVED FURTHER, that in order to promote social distancing and support the government's community quarantine, the Department of Agriculture and the implementing office of the City of Muntinlupa, shall endeavor to prepare materials and conduct the trainings specified in the Memorandum of Understanding via social or any media platforms available.

RESOLVED FINALLY, that a copy of this Resolution be given to the Office of the Department of Agriculture (DA) for their information.
