A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN INTO A SERVICE AGREEMENT (SA) WITH INTEGRATED WASTE MANAGEMENT, INC., (TRANSPORT/TREATER) FOR THE COLLECTION AND TRANSPORTATION OF HAZARDOUS HEALTHCARE WASTE FROM THE CITY GOVERNMENT OF MUNTINLUPA.

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**

WHEREAS, Section 22(a) (4-5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "every local government unit, as a corporation, shall have the following powers:

WHEREAS, Section 22(c) of the same Code further provide that, *"unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned"*;

WHEREAS, the **Integrated Waste Management Inc., (Transporter/Treater)** is a corporation duly organized and existing under the laws of the Republic of the Philippines with business address at 3rd Floor, CargoHaus Building, NAIA Complex, Barangay Vitalez, Parañaque City;

WHEREAS, the Integrated Waste Management Inc., (Transporter/Treater) agrees to serve the City government of Muntinlupa (Generator) by collecting and transporting its hazardous healthcare waste;

WHEREAS, the effectivity and duration of this Service Contract is from April 2020 to March 2021;

WHEREAS, the City Government of Muntinlupa (Generator) shall pay **Integrated Waste Management Inc., (Transporter/Treater)** a service fee of **Three Thousand Five Hundred Pesos (Php3,500.00)** per month inclusive of VAT for waste volume of **0 to 100 kilograms** per month, if volume is more than 100 kilograms, the excess will be computed at **Thirty-Five Pesos (Php35.00)** per kilogram;

WHEREAS, the **Integrated Waste Management Inc., (Transporter/Treater)** shall collect healthcare waste from City Government of Muntinlupa (Generator) twice (2) a month based on the schedule to be determined and provided by the Transporter/Treater;

NOW, THEREFORE, BE RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the **Service Agreement (SA)** with Integrated Waste Management, Inc., (Transport/Treater) for the collection and transportation of hazardous healthcare waste from the City Government of Muntinlupa

APPROVED, by 9th Sangguniang Panlungsod of Muntinlupa this 27th day of April, 2020, on its 42nd Regular Session.
