WHEREAS the Local Government under Section 16, provides that, "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Republic Act No. 7160, Section 458, "the Sangguniang Panlungsod, as legislative body of the city is empowered to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and provide relief services and assistance to victims during and in the aftermath of said disasters or calamities";

WHEREAS, likewise the Local Government Code, provides that, "the Sangguniang Panlungsod may appropriate funds for the construction and maintenance or the rental of buildings for the use of the city";

WHEREAS, under the Local Government Code of 1991, the Sanggunian has the power to approve measures and adopt regulations to prevent the introduction and spread of diseases;

WHEREAS, on April 15, 2020, the City Mayor signed a Memorandum of Agreement (MOA) with Hotel 10/10, an establishment located at Barangay Alabang, Muntinlupa City whereby the Local Government Unit (LGU) shall for a fee, allow the City of Muntinlupa the use of sixty (69) rooms and facilities for the entire duration of Covid-19 pandemic, and even after the Enhance Community Quarantine (ECQ) has been lifted, as may be necessary;

WHEREAS, the agreement is necessary due to the increasing number of Covid-19 positive persons, suspects and probable infected constituents of Muntinlupa as the Ospital of Muntinlupa is no longer able to accommodate additional patients due to its limited bed capacity;

WHEREAS, to prevent further community transmission of the virus, it is the policy to quarantine and isolate suspected, probable and Covid-19 positive patients including the frontliners who will give medical services to them;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, By The 9th Sangguniang Panlungsod of Muntinlupa, to ratify the Memorandum of Agreement (MOA) to entered into by Muntinlupa City represented by the City Mayor Atty. Jaime R. Fresnedi and the Management of Hotel 10/10 for the use of Hotel 10/10 as Quarantine and Isolation Facility for Suspected, Probable and Confirmed Covid -19 Patients as well as the Frontliners giving aid to the said patients.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa, this 27th day of April, 2020, on its 42nd Regular Session.
