WHEREAS, Section 16, of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its husiness transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Sovernment without prior authorization by the Sanggunian."

WHEREAS, the Department of Interior and Local Government issued Memorandum Circular No. 2020-063, entitled, "an Interim Guidelines on the Management of Human Remains for Patient Under Investigation (PUI) and Confirmed Corona Virus Disease 2019 (COVID-19) Cases";

WHEREAS, one of the guidelines provided in Memorandum Circular No. 2020-063, "mandates the Local Government Unit to designate and commission reputable funeral parlors and crematoriums to handle the remains of confirmed COVID-19 cases and Patient Under Investigation (PUIs), and provide possible financial assistance to cover the logistics, fuel, salary and other expenses that will be incurred in the process which include transfer/transport of human remains";

WHEREAS, in compliance thereto, the City Government of Muntinlupa sought the services of Zenaida Lim De Mesa Memoria! Chapel a leading and reputable funeral parlor operating in the City and has the capacity to handle the remains of confirmed COVID-19 cases and PUIs in terms of equipment, manpower and facilities;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to represent the City of Muntinlupa in a Memorandum of Agreement (MOA) with Zenaida Lim-De Mesa Memorial Chapel represented by Mrs. Jennifer F. Laconico for the management of human remains for Person Under Investigation (PUI) and confirmed Corona-Virus Disease (COVID-19) cases.
