FRESNED IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO SIGN AND ENTER INTO A STATEMENT OF PARTNERSHIP WITH THE DEPARTMENT OF AGRICULTURE (DA) REPRESENTED BY SECRETARY WILLIAM D. DAR, PH.D. REGARDING THE AVAILMENT OF MODALITIES UNDER THE KADIWA NI ANI AT KITA PROJECT.

WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, "*The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx.*";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "*(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "*unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.*";

WHEREAS, the Department of Agriculture (DA) launched the "Plant, Plant, Plant, Program" or Ahon Lahat, Pagkaing Sapat (ALPAS) kontra COVID-19, on top of its other existing programs, in order to provide assistance, financial and otherwise, to cooperatives and other groups and individuals adversely affected by the Enhanced Community Quarantine (ECQ) brought about by Coronavirus Disease 2019 (COVID-19) pandemic;

**WHEREAS**, the Department of Agriculture (DA) through its **Memorandum No. 06, series 2020** provides the **Implementing Guidelines** for the delivery of food and other agricultural commodities, to, from, and passing through the National Capital Region (NCR) during the **Enhanced Community Quarantine (ECQ)**;

**WHEREAS**, the **Kadiwa ni Ani at Kita Project**, anchored in the Ahon Lahat, Pagkaing Sapat (ALPAS) kontra Covid-19 Program and in relation to **DA Memorandum No. 6, series 2020**, rolls out an immediate intervention for food production and availability, food accessibility, affordability, and price stabilization during the COVID-19 emergency situation through partnership with the City/Barangay Local Government Units (C/B LGUs) and Homeowner's Associations in the National Capital Region (NCR);

**WHEREAS**, under the DA Manual of Operations on Upscaling KADIWA ni Ani at Kita Project (DA Manual of Operations) and the statement of partnership there are three modalities available to the City Government of Muntinlupa;

**WHEREAS**, the DA Manual of Operations provides that, the City of Muntinlupa shall identify the KADIWA ni Ani at Kita Program modality it wants to participate by signing the statement of partnership";

**WHEREAS**, the following local offices with related functions, among others, are tasked to implement the provisions under the Statement Partnership on the KADIWA ni Ani at Kita Project, and to conduct pertinent actions thereon, in consideration with the DA Central Office;

1. **Department of Agriculture-Extension Services Office (DA-ESO);**
2. **Muntinlupa City Public Market (MCPM);**

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and enter into a Statement of Partnership (SOP) with the Department of Agriculture (DA) represented by Secretary William D. Dar, Ph.D. regarding the availment of modalities under the Kadiwa Ni Ani at Kita Project.

**RESOLVED FURTHER**, that a copy of this Resolution be given to the **Department of Agriculture (DA)** for their information.
