SOLIMAN FOUNDATION, INC., REPRESENT BY JOMERITO S. SOLIMAN, DONATING ONE (1) UNIT OF DISINFECTING CANON IN THE AMOUNT OF ONE MILLIO FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00)

WHEREAS, under Section 15, Article II of the Philippines Constitution, it is the State's policy to protect and promote the right to health of the people;

WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 (LGC) provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, in March 2020, President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929, declaring a State of Public Health Emergency and State of Calamity, respectively, throughout the Philippines to contain the spread of Coronavirus Disease 2019 (COVID-19) in the Philippines;

WHEREAS, on 24 March 2020, the Congress through the "Bayanihan to Heal as One Act" (R.A. No. 11469) declared a State of National Emergency over the entire country to respond efficiently to the crisis brought by the pandemic and to accentuate the urgent need to mitigate, if not contain, the transmission of COVID-19.

WHEREAS, Section 4(j) of the Bayanihan to Heal as One Act empowers the President to *"ensure that donation, acceptance, and distribution of health products intended to address the COVID-19 public health emergency are not unnecessarily delayed;"*

WHEREAS, the Rosita S. Soliman Foundation, Inc., an institution duly established under Philippine Laws, with principal address at 2025 Ipil Street, Sta. Cruz, Manila, and its Chairman, **Jaoquin G. Soliman**, represented by his son, **Jomerito S. Soliman**, expressed their sense of civic duty, generosity, and liberality to contribute in the nationwide efforts to prevent, treat, and fight the pandemic brought by emerging infectious disease affecting the health of their fellowmen;

WHEREAS, the Rosita S. Soliman Foundation, Inc. freely and voluntarily give, transfer, and convey, by way of donation to the City Government of Muntinlupa, one (1) unit of Disinfecting Canon (without reagents or disinfectant included) amounting to One Million Five Hundred Thousand Pesos (Php1,500,000);

WHEREAS, Section 455 (b)(1)(vi) of the LGC provides that, *"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";*

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, authorizing **Mayor Jaime R. Fresnedi** to represent and sign, in behalf of the City Government of Muntinlupa, the Deed of Donation with **Rosita S. Soliman Foundation, Inc.,** represented by **Jomerito S. Soliman**, for its donation of one (1) unit of disinfecting canon in the amount of One Million Five Hundred Thousand Pesos (Php1,500,000.00).
