WHEREAS, Article 86 (v) (1) (vi) and Article 6 (b) (viii) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **"unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, Republic Act No. 11037 otherwise known as **"An Act Institutionalizing a National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition Among Filipino Children, provides for a national feeding program to address undernutrition among Filipino children"**;
