

WHEREAS, Article 86 (v) (1) (vi) and Article 6 (b) (viii) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, Republic Act No. 11037 otherwise known as Institutionalizing a National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition Among Filipino Children, provides for a national feeding program to address undernutrition among Filipino children";

WHEREAS, under Republic Act No. 11037, the Department of Social Welfare and Development, in coordination with the LGUs concerned, "shall implement a supplemental feeding program for under nourished children with ages three (3) to five years. The feeding program shall be administered in a day care centers or in any other facility which can be used for such purpose";

WHEREAS, on March 12, 2020, Proclamation No. 22 was issued, "Declaring a State of Public Health Emergency, relative to the Covid-19 Pandemic, and the passage of Republic Act 11469, otherwise known as the "Bayanihan to Heal as One Act", where national government shall provide unified interventions to create safety nets to curtail the impact of health emergencies to vulnerable sectors;

WHEREAS, the DSWD issued Memorandum Circular NO. 12 series of 2020 also known as "Guidelines in the Implementation of the Supplementary Program During the Community Quarantine Period and Similar Emergencies to ensure that the nutritional needs of target children are met adopting a modified modality for Supplementary Feeding Program";

WHEREAS, the City Government of Muntinlupa, in pursuance of its vision of as a leading investment hub in the country with, educated, healthy, and God-loving people, is fully supportive of the national program having adopted Resolutions 17-209 and 19-115 for the feeding program's previous local implementations;

WHEREAS, the modified modality for Supplementary Feeding Program adopted in the Memorandum of Agreement (MOA) shall benefit more or less Eight Thousand Five Hundred Thirty-Three (8,533) children at Fifteen Pesos (Php15.00) per day for the period of June to August 2020 without cost to the City Government of Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development represented by Regional Director Vicente Gregorio B. Tomas for the Supplementary Feeding Program in Child Development Centers and Supervised Neighborhood Play Areas.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 8th day of June 2020, on its 48th Regular Session.
