A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REPRESENTED BY SECRETARY EDUARDO M. AÑO ON THE INTRODUCTION OF A SMART SOLUTION AND SYSTEM INTEGRATION TO COMBAT CRIME, EMERGENCY MANAGEMENT AND DISASTER MITIGATION BY INSTITUTIONALIZING A COMMUNITY-BASED MONITORING SYSTEM

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, one of the DILG's mandate is to promote the Constitutional principle of maintenance of peace and order, protection of life, liberty and property, and the promotion of general welfare. IN pursuance of which, the goal of institutionalizing a Community Based Monitoring System (CBMS), essential to generate baseline data of information for security diagnosis, monitoring, as well as for effective and efficient planning, budgeting, programming and impact monitoring;

WHEREAS, the institutionalization of the above stated System was approved by the National Economic Development Authority, Investment Coordination Committee but in order for the Project to be effective, the participation of the local government units is essential;

WHEREAS, the City of Muntinlupa, pursuant to Section 25 of the Local Government Code of 1991, which states that, ***"National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects", supports the Project"***;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) with the Department of Interior and Local Government (DILG) represented by **Secretary Eduardo M. Año** on the introduction of a Smart Solution and System Integration to Combat Crime, Emergency Management and Disaster Mitigation by Institutionalizing a Community-Based Monitoring System.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 8th day of June 2020, on its 48th Regular Session.
