FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH GEMWEALTH CONSTRUCTION & TRADING FOR THE PROJECT REHABILITATION OF HALF COURT LOCATED AT FREEWILL, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED NINETEEN THOUSAND TWO HUNDRED NINETY PESOS (PHP1,619,290.00) WHICH AMOUNT SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET UNDER INFRA FUND

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project *rehabilitation of half court located at Freewill*, *Barangay Putatan, Muntinlupa City* in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on February 27, 2020;

WHEREAS, one (1) Bidder submitted their Bid on February 27, 2020 and bidder Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, Gemwealth Construction & Trading's bid has been responsive to Approved Budget for the Contract (ABC) amounting to One Million Five Hundred Twenty-Two Thousand Four Hundred Seventeen Pesos and 65/100 (Php1,522,417.65);

WHEREAS, the project was awarded to Gemwealth Construction & Trading who being the lowest bidder for the project rehabilitation of half court located at Freewill, Barangay Putatan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime RC Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Gemwealth Construction & Trading for the project rehabilitation of half court located at Freewill, Barangay Putatan, Muntinlupa City in the amount of One Million Six Hundred Nineteen Thousand Two Hundred Ninety Pesos (Php1,619,290.00) which amount shall be taken from 2020 Executive Budget under Infra Fund.
