FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH M2 BUILDERS CORPORATION FOR THE PROJECT CONSTRUCTION OF DRAINAGE SYSTEM AND ROAD LOCATED AT #22 PUROK 4, SAN GUILLERMO, BARANGAY BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED NINETY-THREE THOUSAND FOUR HUNDRED THIRTY-THREE PESOS (PHP1,793,433.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET NO. 2 UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, the City Government of Muntinlupa advertisement advertised the invitation to apply for eligibility and to bid for the project **construction of drainage system and road located at #22 Purok 4, San Guillermo, Barangay Bayanan, Muntinlupa City** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **February 4, 2020**;

WHEREAS, one (1) Bidder who submitted their Bid on **February 4, 2020** and bidder Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **M2 Builders Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **One Million Seven Hundred Ninety-Nine Thousand One Hundred Eighty-Four Pesos and 24/100 (Php1,799,184.24)**;

WHEREAS, the project was awarded to **M2 Builders Corporation** who being the lowest bidder for the **project construction of drainage system and road located at #22 Purok 4, San Guillermo, Barangay Bayanan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **M2 Builders Corporation** for the **project construction of drainage system and road located at #22 Purok 4, San Guillermo, Barangay Bayanan, Muntinlupa City** in the amount of **One Million Seven Hundred Ninety-Three Thousand Four Hundred Thirty-Three Pesos (Php1,793,433.00)** which amount shall be taken from **2019 Supplemental Budget No. 2** under **20% Community Development Fund (CDF)**.




