A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH A.P. MELENDREZ CONSTRUCTION INC., FOR THE PROJECT INSTALLATION OF STEEL CEMENT PANEL-HIGH PRESSURE LAMINATE (HPL) RAISED FLOOR FOR COMMAND CONTROL COMMUNICATION (C3)/EMERGENCY OPERATIONS CENTER (EOC) LOCATED AT RESILIENCY BUILDING, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION FIVE HUNDRED THIRTY SEVEN THOUSAND SIX HUNDRED EIGHTY FIVE PESOS (PHP8,537,685.00) WHICH AMOUNT SHALL BE TAKEN FROM SPECIAL TRUST FUND (STF) UNDER THE MUNTINLUPA DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO).
