CAMILLE ALCARAZ OF MATERIALS AND SUPPLIES FOR THE MANUFACTURE OF PERSONAL PROTECTIVE EQUIPMENT (PPE) FOR THE FRONT LINERS AND MEDICAL HEALTH WORKERS IN THE CITY OF MUNTINLUPA

WHEREAS, under Section 15, Article II of the Philippines Constitution, "it is the State's policy to protect and promote the right to health of the people";

WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 (LGC) provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, in March 2020, President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929, declaring a **State of Public Health Emergency** and **State of Calamity**, respectively, throughout the Philippines to contain the spread of Coronavirus Disease 2019 (COVID-19) in the Philippines;

WHEREAS, on 24 March 2020, the Congress through the "**Bayanihan to Heal as One Act**" (R.A. No. 11469) declared a **State of National Emergency** over the entire country to respond efficiently to the crisis brought by the pandemic and to accentuate the urgent need to mitigate, if not contain, the transmission of COVID-19.

WHEREAS, Section 4(j) of the Bayanihan to Heal as One Act empowers the President to *"ensure that donation, acceptance, and distribution of health products intended to address the COVID-19 public health emergency are not unnecessarily delayed"*;

WHEREAS, Section 455 (b)(1)(vi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, *"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance"*;

WHEREAS, the Lingkod Muntinlupa Foundation, Inc., a non-stock, non-profit organization, organized and existing in accordance with the Philippine laws, with principal office address at the 3rd Floor, No. 52, Joval I Building, Barangay Putatan, Muntinlupa City represented by **Atty. Camille Alcaraz**, sense of civic duty, generosity and liberality on its part to contribute to the mitigation of the global pandemic which is now being suffered by COVID-19 patients of Muntinlupa, freely and voluntarily give, transfer, and convey, by way of donation to the City Government of Muntinlupa, the following materials and supplies for the manufacture of **Personal Protective Equipment (PPE)** as follows:

1. 106 rolls of Microfiber fabric
2. Accessories such as garter, needle, thread, string, etc.,

WHEREAS, the Lingkod Muntinlupa Foundation, Inc., coursed the donated materials through the Muntinlupa City Technical Institute (MCTI) which shall engage in the production/manufacture of PPE's for the front liners and medical health workers in the City of Muntinlupa to fight the COVID-19 threat to the people of the City of Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize **Mayor Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa to accept the donation of Lingkod Muntinlupa Foundation, Inc., represented by **Atty.
