A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH JOYRIDE AND HAPPY MOVE (WE MOVE PEOPLE AND THINGS PHILIPPINES, INC.).

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

WHEREAS, due to the spread and continuing threat of Corona Virus Disease (COVID-19), the entire Island of Luzon was placed in Enhanced Community Quarantine (ECQ) on March 16, 2020, pursuant to Proclamation No. 929, series of 2020, by President Rodrigo Roa Duterte;

**WHEREAS**, Metro-Manila and other local government units in Luzon were subsequently placed under General Community Quarantine which likewise restrict the movement of people and imposed health protocols;

**WHEREAS**, the pandemic, a health issue, has an economic impact due to the imposed restrictions halting almost all commercial activities;

**WHEREAS**, the transport sector is one of the many businesses and communities heavily affected by the challenging economic conditions caused by the COVID-19 pandemic;

**WHEREAS**, in order to mitigate the lack or insufficient income of the tricycle drivers and operators, **Joyride and Happy Move**, a legitimate technology company, which operates and maintains online platform, software or mobile application for item, parcel, or package delivery and enable persons seeking delivery or transportation services to be matched with independent service providers, offered its services to the City Government of Muntinlupa;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi** to enter and sign the **Memorandum of Agreement (MOA)** in behalf of the City Government of Muntinlupa with **We Move People and Things Philippines, Inc.**, (**Joyride and Happy Move**).

**RESOLVED FURTHER**, that **We Move People and Things Philippines, Inc.**, (**Joyride and Happy Move**) shall endeavor to remit/pay the tricycle driver/operator who shall participate in the program the amount corresponding to **eighty percent (80%)** of the gross earnings of the completed transaction and the remaining **twenty percent (20%)** shall inure to the benefit of the company.

**ADOPTED**, by the 9<sup>th</sup> **Sangguniang Panlungsod** of this 22<sup>nd</sup> day of **June 2020**, on its 50<sup>th</sup> **Regular Session**.
