A RESOLUTION ADOPTING THE 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) AMOUNTING TO ONE BILLION TWO HUNDRED EIGHTY THREE MILLION TWO HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED PESOS AND 68/100 (PHP1,283,217,400.68) TO ADDRESS COVID-19 FUNDING SOURCES WHICH AMOUNT SHALL BE TAKEN FROM THE MISCELLANEOUS OPERATING AND OTHER EXPENSES AND CAPITAL OUTLAY OF VARIOUS OFFICES (CURRENT YEAR 2020) AMOUNTING TO ONE BILLION ONE HUNDRED EIGHTY-TWO MILLION FOUR HUNDRED FORTY THOUSAND EIGHT HUNDRED FORTY PESOS AND 68/100 (PHP1,182,440,840.68) AND FROM BAYANIHAN GRANT TO CITIES UNDER LOCAL BUDGET CIRCULAR NO. 124 ISSUED ON MARCH 26, 2020, AMOUNTING TO ONE HUNDRED MILLION SEVEN HUNDRED SEVENTY SIX THOUSAND FIVE HUNDRED SIXTY PESOS (PHP100,776,560.00) AS CERTIFIED BY THE CITY ACCOUNTANT AND CITY TREASURER.

WHEREAS, Section 417 of the IRR of the LGC of 1991 as amended by Administrative Order 47, series of 1993 provides that no ordinance providing for a supplement budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenue sources;

WHEREAS, President Rodrigo R. Duterte issued Proclamation Nos. 922 and 929, s. 2020 declaring a state of public, Health Emergency and state of calamity, respectively, throughout the Philippines to afford ample latitude to utilize and appropriate funds in disaster preparedness and response efforts to contain the spread of Coronavirus Disease 2019 (COVID-19) in the Philippines;

WHEREAS, the DBM issued Local Budget Circulars 124 and 125 series of 2020, which provides for the Policy Guidelines on the Provision of Funds by Local Government Units for Programs, Projects, and Activities to Address the Corona Virus Disease 2019 (Covid-19) Situation and Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities, respectively;

WHEREAS, on March 30, 2020, the Department of Interior and Local Government and the Department of Budget and Management issued Joint Budget Circular No. 2, the Provisional Guidelines on the Preparation and Approval of the Annual Investment Programs of the Local Government Units in view of the Coronavirus Disease 2019 (COVID-19) situation;

WHEREAS, on June 1st, 2020, pursuant to the aforementioned national issuances, the Sangguniang Panlungsod enacted **Ordinance 2020-101** authorizing the realignment of the Annual Budget for the calendar year 2020 in the total amount of **One Billion Two Hundred Eighty-Three Million Two Hundred Seventeen Thousand Four Hundred Pesos and 68/100 (Php1,283,217,400.68)** to address Covid-19 funding, which are sourced as follows:
