FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH AYANA CONSTRUCTION CORPORATION FOR THE PROJECT SITE DEVELOPMENT OF PLAYGROUND LOCATED AT CENTENNIAL ROAD, LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY, AMOUNTING TO TWO MILLION THREE HUNDRED SEVENTY-FOUR THOUSAND ONE HUNDRED EIGHTY-ONE PESOS AND 46/100 (PHP2,374,181.46) WHICH AMOUNT SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET UNDER INFRA FUND.
