WHEREAS, one (1) Bidder who submitted their Bid on February 27, 2020 and bidder Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, Ayana Construction Corporation's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Two Million Three Hundred Eighty-Three Thousand Six Hundred Twenty-One Pesos and 74/100 (Php2,383,421.74);

WHEREAS, the project was awarded to Ayana Construction Corporation, who being the lowest bidder for the project Site Development of Playground located at Centennial Road, Laguerta, Barangay Tunasan, Muntiniupa City;
