A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH AYANA CONSTRUCTION CORPORATION FOR THE PROJECT REHABILITATION OF DRAINAGE SYSTEM AND PATHWAY LOCATED AT BLOCK 5, PUROK 3, BAGONG PARAISO, BARANGAY BAYANAN, MUNTINLUPA CITY AMOUNTING TO FIVE MILLION TWO HUNDRED ELEVEN THOUSAND FIVE HUNDRED FORTY-NINE PESOS AND 50/100 (PHP5,211,549.50) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET NO. 2 UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

**WHEARES**, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Ayana Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Five Million Two Hundred Forty-One Thousand Five Hundred Fifty-Eight Pesos and 66/100 (Php5,241,558.66)**;
