A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. **WHEREAS**, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **fabrication of fences located at Alabang-Zapote-Road In between Market Drive and Alabang Viaduct, Barangay Alabang, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **March 10, 2020**;

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Gemwealth Construction & Trading's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million Three Hundred Thirty Thousand Eight Hundred One Pesos and 20/100 (Php2,330,801.20)**;

**WHEREAS**, the project was awarded to **Gemwealth Construction & Trading** who being the lowest bidder for the project **fabrication of fences located at Alabang-Zapote-Road In between Market Drive and Alabang Viaduct, Barangay Alabang, Muntinlupa City**;




