WHEREAS, through the initiative of the Office of Congressman Ruffy Biazon, the Department of Public Works and Highways (DPWH) designed and budgeted the proposed drainage construction and concreting of the whole stretch of M.L. Quezon covering the portion of Cupang, Muntinlupa City ("the Project");

WHEREAS, on November 19, 2019, the Barangay Council of Cupang conducted a public consultation together with residents of Barangay Cupang, representatives from DPWH, City Engineering Office, Office of Congressman Ruffy Biazon, and other attendees, for the purpose of informing the residents of the forthcoming Project;

WHEREAS, the Project started sometime in January 2019;

WHEREAS, during the initial stages of construction, the residents realized that the design of the Project would pose problems that will affect their properties;

WHEREAS, on July 2, 2020, due to the clamor of the residents, the Barangay Council of Cupang once again conducted a consultation together with representatives from DPWH, Maynilad, City Engineering Office, Members of the City Council, and the concerned residents;

**WHEREAS**, during the said hearing, the **DPWH** acceded to the request of the residents for a variation of the initial design that instead of installing a Reinforced Concrete Pipe type of drainage, a box culvert and elevated concrete pavement will be constructed at its original level;

**WHEREAS**, the **DPWH** said that as a consequence of the variation of the initial design, the original coverage of the Project will be reduced because box culvert is more expensive, and suggested to include additional budget for the request for variation to be implemented;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the **9<sup>th</sup> Sanggunian Panlungsod of Muntinlupa** on session assembled, to request the **DPWH**, through the **Office of Congressman Rufino Rozano R. Biazon**, for a variation of the original design of the Project;

**RESOLVED, FURTHER**, to request for additional budget to augment the Project as a result of the proposed variation.

**RESOLVED, FINALLY**, that copy of this resolution be given to the **Office of Congressman Rufino Rozano R. Biazon** and the **Office of Department of Public Works and Highway (DPWH)** for their information.
