



A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE COLEGIO DE MUNTINLUPA (CDM) WITH LAND BANK OF THE PHILIPPINES (LBP) REPRESENTED BY CECILIA C. BOROMEO, PRESIDENT AND CHIEF EXECUTIVE OFFICER, AND HER DULY AUTHORIZED REPRESENTATIVE, SYNPHA B. MALTO, HEAD, MUNTINLUPA CITY BRANCH ON THE MATTER OF LBP AS PAYMENT SERVICE PROVIDER (PSP) FOR PAYMENT OF MONETARY OBLIGATIONS DUE TO THE CDM FROM ITS STUDENTS

WHEREAS, Section 22(a) (4-5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "every local government unit, as a corporation, shall have the corporate power to enter into a contract;

WHEREAS, Section 22(c) of the same Code further provide that, "unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";

WHEREAS, Section 16 of the LGC provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, in March 2020, President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929, declaring a State of Public Health Emergency and State of Calamity, respectively, throughout the Philippines to contain the spread of Coronavirus Disease 2019 (COVID-19) in the Philippines;

WHEREAS, following the mandate of its office, the Inter-Agency Task Force (IATF), issued various resolutions providing for guidelines and protocols to be followed in phases of Community Quarantines being issued for different areas in the country;

WHEREAS, Section 4, paragraph no. 11 of the IATF Omnibus Guidelines states that, "the face-to-face or in-person classes shall be suspended, thus, the further restriction in the use of the school premises during the imposition of community quarantine";

WHEREAS, Section 4, paragraph no. 14 of the IATF Omnibus Guidelines provides that, "the road, rail, maritime, and aviation sectors of public transportation shall operate at a reduced operational and vehicle capacity in accordance with guidelines issued by the Department of Transportation";

WHEREAS, on 19 June 2020, Dr. Teresita C. Fortuna, Acting College President of the Colegio de Muntinlupa (CDM), through a letter addressed to the City Mayor Atty. Jaime R. Fresnedi, manifested the intent of CDM to adopt a convenient payment option for its stakeholders who do not have access to public transportation brought about by the ongoing community quarantine;

WHEREAS, on 19 June 2020, the CDM-Board of Trustees authorized Mayor Jaime R, Fresnedi to enter into a Memorandum of Agreement (MOA) with Land Bank of the Philippines for <u>Online Mode of Payment of Students' Fees</u>, subject to the standard operating procedure in the execution of agreement;

WHEREAS, under the MOA, the LandBank shall collect, *in accordance with* standard business practices and as agreed upon by the CGM and LBP, reasonable transaction fees for both the existing and new payment options from the CDM clients to recover the cost of the implementation of the LBP Link.BizPortal enhancements on the use of various payment options as follows":
