WHEREAS, Section 22(a) (4-5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, **“every local government unit, as a corporation, shall have the corporate power to enter into a contract”**;

WHEREAS, Section 22(c) of the same Code further provide that, **“unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”**;

WHEREAS, Section 16 of the LGC provides that, **“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance”**;
