WHEREAS, Section 22(a) (4-5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, **"every local government unit, as a corporation, shall have the power to enter into a contract;**

WHEREAS, Eurolink Network International Corporation is an independent contractor and third party Electronic Claims (eClaims) Health Information Technology Provider (HITP) duly authorized, accredited and license by the Philippine Insurance Corporation (PHILHEALTH) to engage in PHILHEALTH benefit claims transactions management with HCI Client for the purpose of providing access to PHILHEALTH'S eClaims utility framework to the latter through Eurolink's "Easy Claims application software;

WHEREAS, the City Government of Muntinlupa – TB Dots Package Provider, a **Health Care Institute (HCI)** duly organized and existing under and by virtue of the laws of the Philippines entered into a MOA with Eurolink for its services to Barangay Health Center by virtue of Resolution No. 2020-204;
