FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDC) REPRESENTED BY VICE-CHAIRPERSON AND EXECUTIVE DIRECTOR DR. TERESITA G. INCIONG FOR THE FUNDING SUPPORT FOR INSTRUCTIONAL MATERIALS TO TEN (10) DAY CARE CENTERS IN THE CITY OF MUNTINLUPA IN THE AMOUNT OF ONE MILLION PESOS (PHP1,000,000.00).

**WHEREAS**, Section 2 of Republic Act No. 10410, otherwise known as the Early Years Act, has declared a state policy to institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative, and sustainable that will involve multi-sectoral and interagency collaboration at the national and local level among government, among service providers, families and communities, and among the public and private sectors, non-government organizations, professional organizations and academic institutions;

**WHEREAS**, Section 6 of Republic Act No. 10410, also provides that the National ECCD System shall henceforth apply to all provinces, cities and municipalities and barangays as maybe determined by the ECCD Council to achieve universal ECCD coverage for all children from age zero (0) to four (4) years;

**WHEREAS**, Section 11 of R.A. 10410 mandates the ECCD Council for the conversion of the existing Day Care Center into Child Development Centers;

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that ***“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”***;

**WHEREAS**, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, ***“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”***;

**WHEREAS**, as a phase of the progress of the conversion, the ECCD Council will assist ten (10) Day Care Centers where an NCDC has been established by way of human resource development or funding support for instructional materials and/ or renovation/rehabilitation/ completion of DCCs;

**WHEREAS**, the City of Muntinlupa intends to use the funding support for instructional materials and has identified the recipient day care centers which are obliged to comply with the guidelines for conversion of the Day Care Centers into Child Development Centers to ensure that the funds are properly utilized and liquidated;

**WHEREAS**, funding shall be utilized by the City Government of Muntinlupa for the following Day Care Centers and for herein purposes:
