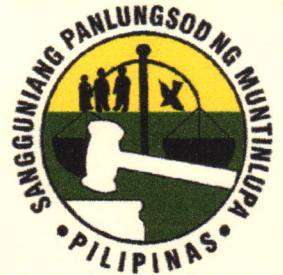

A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA THRU OSPITAL NG MUNTINLUPA AND ASIAN HOSPITAL MEDICAL CENTER FOR THE REFERRAL OF THE COVID SWAB TESTS OF OSMUN PATIENTS TO ASIAN HOSPITAL MEDICAL CENTER MOLECULAR LABORATORY

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "**(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.**";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "**unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.**";

WHEREAS, Philhealth Circular No. 2020-0010 provides that all Filipinos, member of Philhealth, who are classified as eligible for testing based on DOH guidelines, as well as all Covid19 cases that require repeated testing can avail of the Benefit Package for Testing for SARS-CoV-2 and those who are not Philhealth members shall automatically be covered provided they complete member's registration upon availment of the benefit package;

WHEREAS, Philhealth Circular 2020-0010 setforth the case-based benefits for testing for SARS CoV-2 and the manner how the DOH accredited testing facilities may seek for reimbursement/payment;

WHEREAS, Asian Hospital Inc., a corporation duly organized and existing under the laws of the Republic of the Philippines with principal Office at Civic Drive, Filinvest Barangay Alabang, Muntinlupa City has a DOH accredited molecular laboratory facility which can undertake RT-PCR test for SARS-CoV2 virus of the Covid19;

WHEREAS, Ospital ng Muntinlupa, a local government hospital, sought the services of Asian Hospital Inc., under the terms and conditions setforth in the MOA, to conduct the necessary laboratory test required to ascertain COVID-19 virus on maximum of three (3) specimen samples per day which will be submitted to it by the Ospital ng Muntinlupa;

WHEREAS, in order to recover the cost in performing the services for the patients of Ospital ng Muntinlupa, AHI, as the DOH-RITM certified testing laboratory for COVID-19, shall be responsible in filing for a benefit claim from the Philhealth per Circular No 2020-0010;

WHEREAS, the Sanggunian concurs with Executive Department's recommendation to delete a provision in the MOA particularly letter b of item 3.4 thereof;

WHEREAS, the City Legal Office issued a legal opinion on the Memorandum of Agreement and is recommending the approval of the same.

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) between the City Government of Muntinlupa thru Ospital ng Muntinlupa and Asian Hospital Medical Center Molecular Laboratory for the referral of the Covid Swab Tests of OsMun Patients to Asian Hospital Medical Center.

ADOPTED, by 9th Sangguniang Panlungsod of Muntinlupa, this 27th day of July 2020, on its 55th Regular Session.
