WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;*

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, *“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;*

WHEREAS, PAGCOR is a government owned and controlled corporation (GOCC) organized and existing by virtue of Presidential Decree No. 1869 as amended, with office address at 5F PAGCOR House Annex, Carmen Building, 1105 United Nations Avenue Corner Maria Orosa St., Ermita, Manila and represented in this Deed of Donation by the Vice President of the Corporate Social Responsibility Group (CSRG) James Patrick R. Bondoc;

WHEREAS, due to the Covid-19 Pandemic the PAGCOR decided to help and donate to the City Government of Muntinlupa the relief goods such as rice, noodles and chocolate powdered drink;

Fresnedi in behalf of the City Government of Muntinlupa to sign and accept the Deed of Donation from Philippine Amusement and Gaming Corporation (PAGCOR) represented by Mr. James Patrick R.
