WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that ***“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”***;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, ***“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”***;

WHEREAS, the Church of Jesus Christ of Latter-Day Saints donated 100,000 pieces of Community Grade Washable Face Mask to the City Council of Muntinlupa

- b. That the items will be distributed for free to those in need and not be sold nor used for any commercial purpose;

WHEREAS, the City further acknowledge that the donated face masks are non-medical grade nor made to meet any health standards;

WHEREAS, the City Legal Office finds the conditions to be reasonable and poses no objection to the said donation;

WHEREAS, due to the Covid-19 Pandemic, The Church of Jesus Christ of Latter-Day Saints decided to help and donate to the City Government of Muntinlupa the 100,000 pieces washable face mask;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th **Sangguniang Panlungsod of Muntinlupa**, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and accept the Deed of Donation from the Church of Jesus Christ of Latter-Day Saints in the Philippines, Inc., represented by the area President Mr. Edgardo E.
