WHEREAS, the Local Government under Section 16, provides that, "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Republic Act No. 7160, Section 458, "the Sangguniang Panlungsod, as legislative body of the city is empowered to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and provide relief services and assistance to victims during and in the aftermath of said disasters or calamities;

WHEREAS, likewise the Local Government Code, provides that, Sangguniang Panlungsod may appropriate funds for the construction maintenance or the rental of buildings for the use of the city";

WHEREAS, under the Local Government Code of 1991, the Sanggunian has the power to approve measures and adopt regulations to prevent the introduction of diseases;

WHEREAS, due to the increasing number of COVID-19 patients in the entire Philippines and in the City of Muntinlupa, isolation is one of the effective remedies to prevent the continuous community transmission;

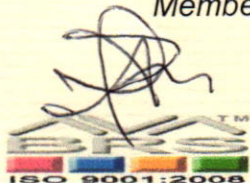
