FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH SIBALOM GLASS ALUMINUM CONSTRUCTION SUPPLY & SERVICES FOR THE PROJECT CONSTRUCTION OF DRAINAGE SYSTEM AND PATHWAYS LOCATED AT SITIO RIZAL FANTASTIC, BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION FORTY ONE THOUSAND SIX HUNDRED NINETY PESOS (PHP2,041,690.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET NO. 2 UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).
