WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibilities, technology and financial requirements submitted by the bidder with lowest calculated bid, V.F. Labao Construction Corporation's, its bid has been responsive to the Approved Budget for the Contract (ABC) amounting to Two Million Thirty-Seven Thousand Three Hundred Sixty-Eight Pesos and 65/100 (Php2,037,368.65);

WHEREAS, the project was awarded to V.F. Labao Construction Corporation, who being the lowest bidder for the project construction of drainage system and pathways located at 184 Buendia, Barangay Tunasan, Muntinlupa City;
