**WHEREAS**, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **rehabilitation of road and drainage located at Block 5, Purok 1, Barangay Bayanan, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, two (2) bidders submitted their letter of intent and application for eligibility and were found eligible on **February 20, 2020**;

**WHEREAS**, there one (1) Bidder submitted its Bid on **February 20, 2020** and Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibilities, technology and financial requirements submitted by the bidder with lowest calculated bid, **Camilo Construction & Trading's**, its bid has been responsive to the **Approved Budget for the Contract (ABC)** amounting to **Two Million Four Hundred Forty-Six Thousand Thirty-Three Pesos and 52/100 (Php2,446,033.52)**;

**WHEREAS**, the project was awarded to **Camilo Construction & Trading** who being the lowest bidder for the project **rehabilitation of road and drainage located at Block 5, Purok 1, Barangay Bayanan, Muntinlupa City**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R.
