WHEREAS, Sec. 9, Article II of the 1987 Philippine Constitution, provides that, "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and its the people from poverty trough policies that provide adequate social services, promote full employment, a rising standard of living and improved quality of life for all";

WHEREAS, Sec. 35 of the Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides that, "Local governments units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people";

WHEREAS, Sec. 36 of said RA 7160 further provides that, "A local government unit may, through its local Chief Executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction";

**WHEREAS**, the Department of Labor and Employment (DOLE), through the Bureau of Workers with Special Concerns (BWSC) implements the DOLE Integrated Livelihood and Emergency Employment Programs (DILEEP) which seeks to contribute to poverty reduction and reduce the vulnerability to risks of the working poor, vulnerable and marginalized workers either through emergency employment, and promotion of entrepreneurship and community enterprises.

**WHEREAS**, the KABUHAYAN PROGRAM is one of the DILEEP being implemented by the DOLE and under such program the **"Dishwashing Liquid Making"** Group Livelihood Formation Project was approved in accordance with the Department Order 173 series of 2017;

**WHEREAS**, under the **"Dishwashing Liquid Making"** Group Livelihood Formation Project, thirty-Nine (39) beneficiaries identified by the City shall benefit from the Two Hundred Four Thousand and Seven Hundred Fifty Pesos (PhP204,750.00) funding to be released by DOLE;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) with Department of Labor and Employment-National Capital Region (DOLE-NCR) represented by Regional Director, Atty. Sarah Buena Mirasol for the implementation of Kabuhayan Program Entitled, **"Dishwashing Liquid Making"** through the Direct Administration of the Local Government Unit of Muntinlupa.






