WHEREAS, Sec. 9, Article II of the 1987 Philippine Constitution, provides that, *"The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and its the people from poverty trough policies that provide adequate social services, promote full employment, a rising standard of living and improved quality of life for all";*

WHEREAS, Sec. 35 of the Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides that, *"Local governments units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people";*

WHEREAS, Sec. 36 of said RA 7160 further provides that, *"A local government unit may, through its local Chief Executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction";*

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **"unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, on July, 2017, through Resolution 17-199, the Sanggunian authorized the release of **One Million Pesos (Php1,000,000.00)** Loan Assistance to **Muntinlupa Science High School Multi-Purpose Cooperative** payable in three (3) years with the condition that MSHS-MPC shall issue post-dated checks in the amount corresponding to the amortization agreed in therein Memorandum of Agreement;

WHEREAS, the Board of Directors of the MSHS-MPC in its meeting held on June 4, 2020, unanimously approved to request for a moratorium in the payment of their loan obligations of the remaining **Three Hundred Thirty-Three Thousand Three Hundred Thirty-Three Pesos and Thirty-Six Centavos (Php333,333.36)** for one (1) year due to their financial conditions as exacerbated by the current pandemic;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor to represent Muntinlupa City in a Memorandum of Agreement with **Muntinlupa Science High School Multi-Purpose Cooperative (MSHS-MPC)** for the deferment of **MSHS-MPC Loan Obligation**.

ADOPTED, by the 9th **Sangguniang Panlungsod of Muntinlupa** this 17th day of August, 2020, on its 58th Regular Session.






