WHEREAS, Sec. 9, Article II of the 1987 Philippine Constitution, provides that, "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and its the people from poverty trough policies that provide adequate social services, promote full employment, a rising standard of living and improved quality of life for all";

WHEREAS, Sec. 35 of the Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides that, "Local governments units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people";

WHEREAS, Sec. 36 of said RA 7160 further provides that, "A local government unit may, through its local Chief Executive and with the concurrence of the Sanggunian concerned; provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction";
