WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, *"The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx."*;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."*;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."*;

**WHEREAS**, the Department of Agriculture (DA) issued Memorandum Circular No. 08 dated 16 March 2020, issued the Implementing Guidelines for the Implementation of Urban Agriculture Program which highlights Urban Agriculture as one of the modalities in making food available, accessible, affordable, and safe; and in approving additional income to the project beneficiaries;

**WHEREAS**, the DA campaigns for the enhancement of Urban Agriculture in Metro Manila amid the threats of the Corona Virus of 2019 (COVID-19) and during the Enhanced Community Quarantine to address the food supply in the Urban cities;

**WHEREAS**, the City Government of Muntinlupa, through the Department of Agriculture Extension Office, recognizes its role in building a sustainable city for its constituents thereby partnering Home Owners Associations (HOAs) to embark on this journey by undertaking to transform underutilized open spaces in subdivisions into places of community empowered food production to generate a sustainable source of food stability during these trying times;

**WHEREAS**, the DA-Extension Services will be leading the implementation of the Urban Gardening Program, that teaches the people in the community to produce their own food, empower them to earn extra income from their produce and learn about food safety especially during this global pandemic;

**WHEREAS**, under the MOA the City Government of Muntinlupa will provide the starter kits to the homeowners' association to develop an urban garden within its subdivision/village;

**WHEREAS**, the Legal Office interposes no objection to the terms and conditions under the MOA;

**WHEREAS**, the said program of the City is very timely and will efficiently utilize the open spaces within the subdivision, reduce carbon emission, provide jobs, promote sustainability and food stability, generate funds for the subdivision and can be a good community building activities;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and enter into a Memorandum of Agreement (MOA) with Homeowners Association (HOA) represented by its President/Chairperson of the board on the matter of enhancing urban agriculture in the National Capital Region (NCR) and implementation of all activities in the City of Muntinlupa.
