A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO REPRESENT THE CITY IN A MEMORANDUM OF AGREEMENT WITH MYTAXI. PH INC. (GRAB PHILIPPINES) REPRESENTED BY ITS PRESIDENT BRIAN, MATHEW CU TO PROVIDE LIVELIHOOD TO FIVE (500) HUNDRED TRICYCLE DRIVERS AND WORK-DISPLACED MOTORCYCLE OWNERS AFFECTED BY THE IMPOSITION OF THE COMMUNITY QUARANTINE IN THE CITY OF MUNTINLUPA DUE TO COVID-19 PANDEMIC

**WHEREAS**, Section 455 (b)(1)9(vi) of the Local Government Code provides that, *"the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod"*;

**WHEREAS**, Republic Act No. 7160, empowers the Sanggunian to approve ordinances and pass resolutions necessary for an efficient and effective government, and in this connection shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following the said events;

**WHEREAS**, the Pandemic Covid-19 prompted the National Government to implement community quarantines to contain the virus which in general imposed lock downs and restriction in the movement of population, immensely affecting the public transportation sector;

**WHEREAS**, while the national government grant unto the local government units the determination on the policy to be implemented for tricycle and pedicab operations during the pandemic, the magnitude of the effect of the restrictions in the movement of people caused severe economic distress to tricycle drivers-resident and work-displaced constituents of Muntinlupa City;

**WHEREAS**, the City Government of Muntinlupa, seeking to alleviate the plight of the said group, sought the assistance from the private sector through the development of partnership agreements with entities, such as Grab, Philippines, Inc.

**WHEREAS**, MYTAXI.PH INC, (Grab Philippines), an on demand food delivery and delivery services platform company represented by its President Mr. Brian Mathew Cu, endeavors to help Muntinlupenos recover from the impacts of COVID-19;

**WHEREAS**, through the GRAB- MUNTINLUPA SOCIO ECONOMIC RECOVERY INITIATIVE PROGRAM (the Program), livelihood to about Five Hundred tricycle drivers and work displaced motorcycle owners who were adversely affected by the Community Quarantine, upon completion of the required training, shall be part of Grab's delivery fleet;

**WHEREAS**, the Program shall likewise provide business opportunities to Micro, Small and Medium Enterprises (MSMEs) that were forced to close down;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to represent the City in a Memorandum of Agreement with **MYTAXI. PH INC. (Grab Philippines)** represented by its **President Brian, Mathew Cu** to provide livelihood to **five (500) Hundred Tricycle Drivers and Work-Displaced Motorcycle** owners affected by the imposition of the Community Quarantine in the City of Muntinlupa due to Covid-19 Pandemic.




